

1. The purpose of this modification is to incorporate Granite's Submission Number GR00192.01a dated March 12, 2019 into the contract. The submission adds the optional service Optical Wavelength Service (OWS) at two (2) previously awarded Core-Based Statistical Areas (CBSAs) to the contract. Additionally, this submission adds a new Network Site Code (NSC) to PHub and NSC to Physical Concentration Location (PCL) mapping assignment which results in producing new Access Arrangement (AA) Monthly Recurring Charge (MRC) prices to an NSC located within a previously awarded CBSA (38300 – Pittsburgh, PA).
2. The estimated dollar value of the contract remains unchanged.
