1. The purpose of this modification is to incorporate Granite's Submission Number GR00195.03a dated June 5, 2019 into the contract. The submission adds eighteen (18) CONUS Core-Based Statistical Areas (CBSAs) and associated prices and mapping relationships to the contract. In addition, this submission proposes to add twelve (12) previously awarded optional services: Circuit Switched Data Service (CSDS), Cable and Wiring (CW), Dark Fiber Service (DFS), Internet Protocol Service (IPS), Internet Protocol Voice Service (IPVS), Labor, Optical Wavelength Service (OWS), Private Line Service (PLS), SONETS, Service Related Equipment (SRE), Toll Free Service (TFS) and Unified Communications Services (UCS) to each of the 18 proposed CONUS CBSAs.
2. The estimated dollar value of the contract remains unchanged.
