1. The purpose of this modification is to incorporate Granite's Submission Number GR00220.02a dated June 21, 2019 into the contract. The submission adds thirteen (13) CONUS Core-Based Statistical Areas (CBSAs), associated prices and mapping relationships to the contract.
